ESPEC CORP. hereby announces that it resolved at the Board of Directors meeting held on March 7, 2025, to revise the consolidated full-year financial forecast and revise the year-end dividend forecast for fiscal 2024, as follows.

#### Reasons for the revisions

Based on the consolidated financial results for the first nine months of fiscal 2024, the year ending March 31, 2025, and result of considering the future outlook, net sales, operating income, ordinary income are now expected to surpass the previously announced financial forecast. In addition, based on its policy of reducing cross-shareholdings, the Company has sold some of its cross-shareholdings, and by recording it under extraordinary income in the fourth quarter of the fiscal ending Marach 31, 2025, profit attributable to owners of parent is expected to surpass the previous forecasts. Accordingly, the Company has upwardly revised the full-year consolidated financial results forecasts for the fiscal year ending March 31, 2025.

### Reasons for the revisions

The company decides dividends in consideration of continuity and consolidated dividend payout ratio, and we regard the return of profits to shareholders as one of our priority management challenges.

In light of the Company's results for the revision of the consolidated full-year financial forecast, the Company has decided to increase the year-end dividend by 15 yen per share to 60 yen.

As a result, the annual dividend forecast is now 95 yen per share.
